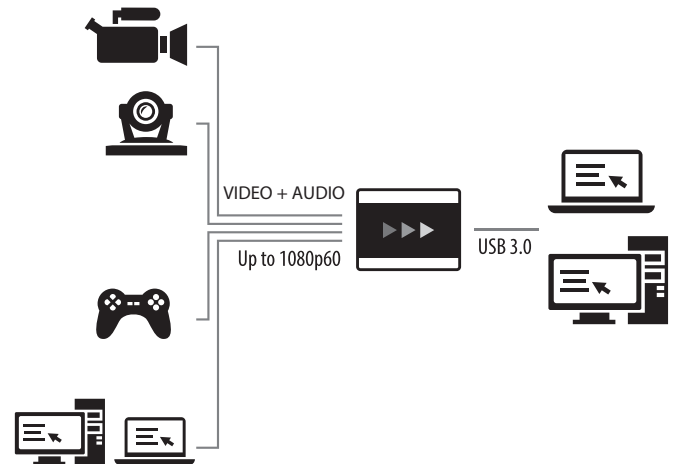

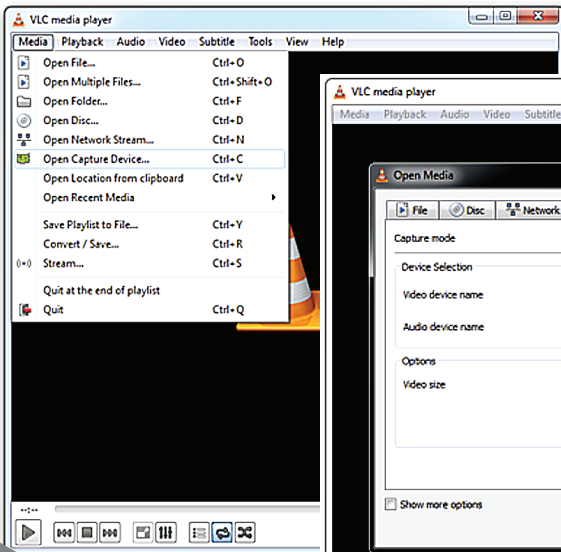
Connection Diagram:

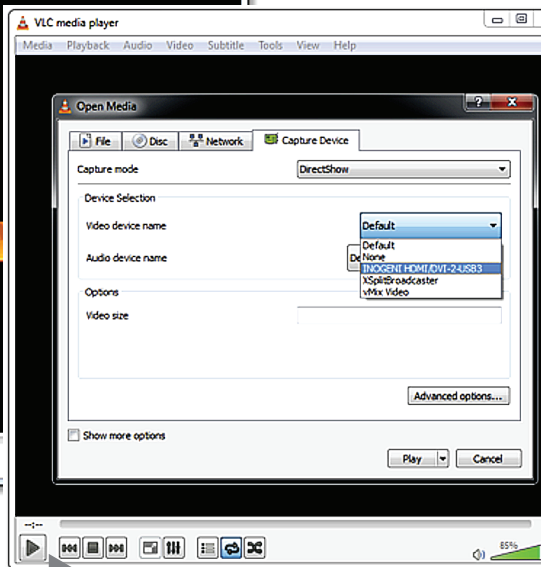

Connect the INOGENI to a USB 3.0 port and to your video source.

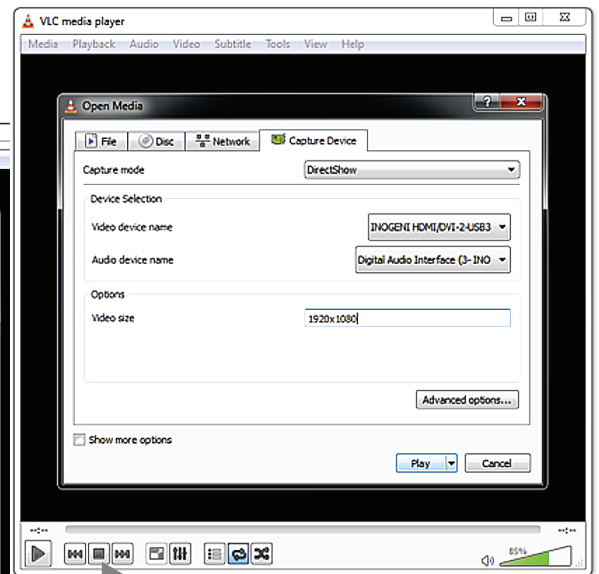


1 Download and run VideoLan VLC player, for Windows, Linux or OSX:  
[www.videolan.org/vlc/index.html](http://www.videolan.org/vlc/index.html)

Go to **Media->Open Capture Device**.



2 Video device name and Audio device name, select your **INOGENI** device.



3 In the **Video size** text box, enter the resolution of your video source, for example 1920x1080.

(if your source is not 60 Hz, go to **Advanced options** and set the frame rate)

Hit **Play!**

You should see and hear your live video!
